These two women and one man are known to follow Christ closely and stand ready to serve our Lord and Savior and His church. These 3 individuals take following Christ seriously. I hope you do too. I hope that you want to be an active part of a church that takes following Christ seriously! If so, you are in the right place. I don't mind telling you that I want to, in sense, make you uncomfortable. I want to "stir up in you the high calling of Jesus Christ" on your life! You see, Jesus didn't pay in blood, so that we could live in ease. Jesus died on the cross, so that you and I could see how to carry ours! The truth is, you don't have to become a Deacon to serve. But those who look up to Jesus, listen to Him, learn from Him, live like Him, love like He loved, will also serve like He served! Will You? Are You?

Deacon Expansion

During this recent Deacon Nomination and selection process, the Senior Pastor and Deacons came to the realization that the current number of Deacons (9) as dictated by the current By-Laws, needs to be changed to **Twelve**. With the church growing in numbers and ministries expanding, the Deacon Body is recommending that the church revise the By-Laws to allow for these additional Deacons for service during this upcoming term.

By-Law Revision

The Current By-Laws in Article IX, Section 4 stipulates that the By-Laws may be "altered by a three-fourths vote of the members present at any regular business meeting providing one month's previous notice is given. The proposed changes will be made available at least two weeks prior to the meeting."

Therefore, this notification is provided well in advance of the 30 day requirement. The specific language addressing the By-Law revision will be provided NLT October 14, 2018 – with a vote occurring at the regular scheduled business meeting on October 28.

Deacon Eligibility

The Senior Pastor and Deacon Body will be recommending the following individuals for consideration:

These five individuals have already been nominated by the church, interviewed by the Senior Pastor and Deacons and are eminently qualified to serve as Deacons. Several received votes during the last voting session. <u>We are asking that the church</u> <u>select an additional three candidates to serve in</u> <u>this current term, beginning on November 1, 2018.</u>

Conclusion

I'll be sharing the details of this process as we move forward with the By-Law revision occurring first, and then the selection of an additional three Deacons by a secret ballot vote – **all on October 28th, during the regular scheduled business meeting.** Stay tuned.

A Word about Preaching

September 26, 2018

Let me begin by saying that I love to preach and I think I'm pretty good at it. At least that's what I am told. I'm also a team oriented person. Dating back to my days as a young boy, through my teen-age years, and into college I was immersed in team sports. I learned during those formative years the importance of performing as an athlete with enthusiasm and excellence. To always do my best. I also learned the value of being part of a team and that my personal performance, no matter how good or bad I did, was overshadowed by the team's performance. We won as a team and lost as a team.

This team orientation was reinforced in the earliest days of my calling into ministry, as I once again served, but this time within the structure of a team of ministers. I had a particular job, a personal calling, but my ministry was not independent but interdependent. This concept grew in complexity and gravity as I was called to serve in the sea services as a Navy Chaplain. I was now part of pluralistic and ecumenical team that encompassed not only various denominations but also faith groups.

All this is to say, that I am a creature of TEAM MINISTRY. Which is a good thing given that Jesus Himself was also a proponent of TEAM MINISTRY. The Gospels tell us that one of the first things He did following His baptism and launching His personal ministry was to seek out and call His Disciples – His Team. Not long after that, Jesus reinforced this idea of TEAM MINISTRY by sending out "the 72" (Luke 10:1-20). These Christ-followers had been exposed to Jesus and His ministry for some time, they had been trained, and seen up close and personal the ministry of Jesus. Now they were tasked to go and do what He Himself was doing.

You may be asking, "Pastor Frank, why are you telling us this?" Well, you may have noticed that I have been sharing the preaching duties with Joseph Pack and Doug Farris. They have preached not only when I have been gone but also when I am not gone. Not too long ago I asked Doug if he would preach a 3-part sermon series. And he did an excellent job. I have also asked Joseph to do the same thing starting **Sunday, October 28th through Sunday, November 11th** (I will be away on only one of those Sundays, October 28th). Also, I will be gone the first Sunday in December, leading some of our members on a trip to the Holy Land, which will require another preacher to bring the message that Sunday.

Let me close by saying that I BELIEVE IN THE NECESSITY AND POWER OF A PREACHING TEAM. I honestly believe that this can lead to a healthier and more sustainable proclamation ministry and I believe we will see more fruit as a result. Next month I'll do a deeper dive into why I think a preaching team is best suited for BGBC.

- Inflatable


